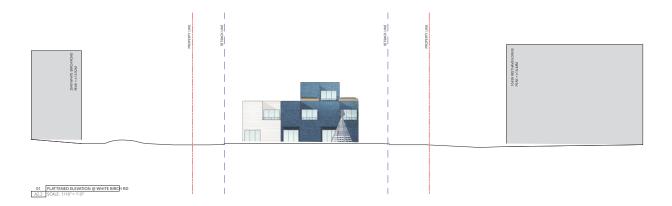


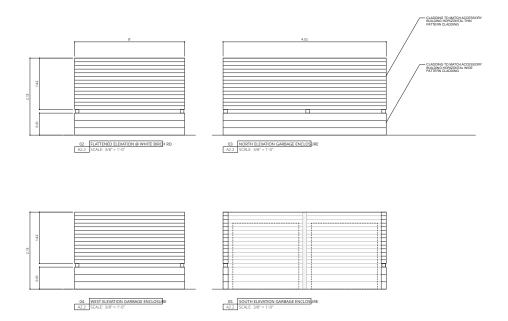


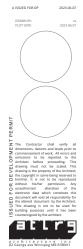












STREET ELEVATION

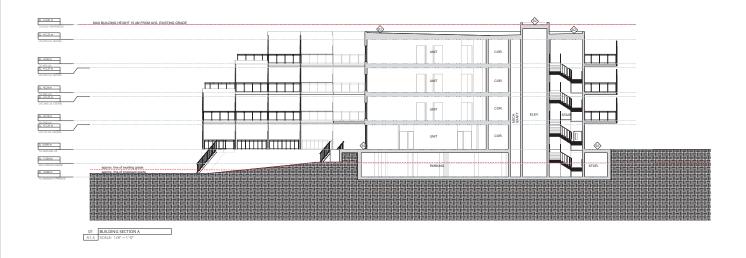

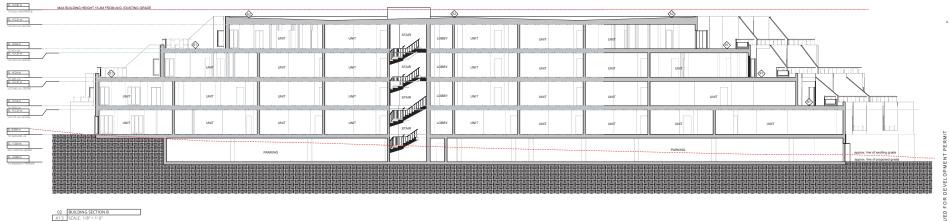

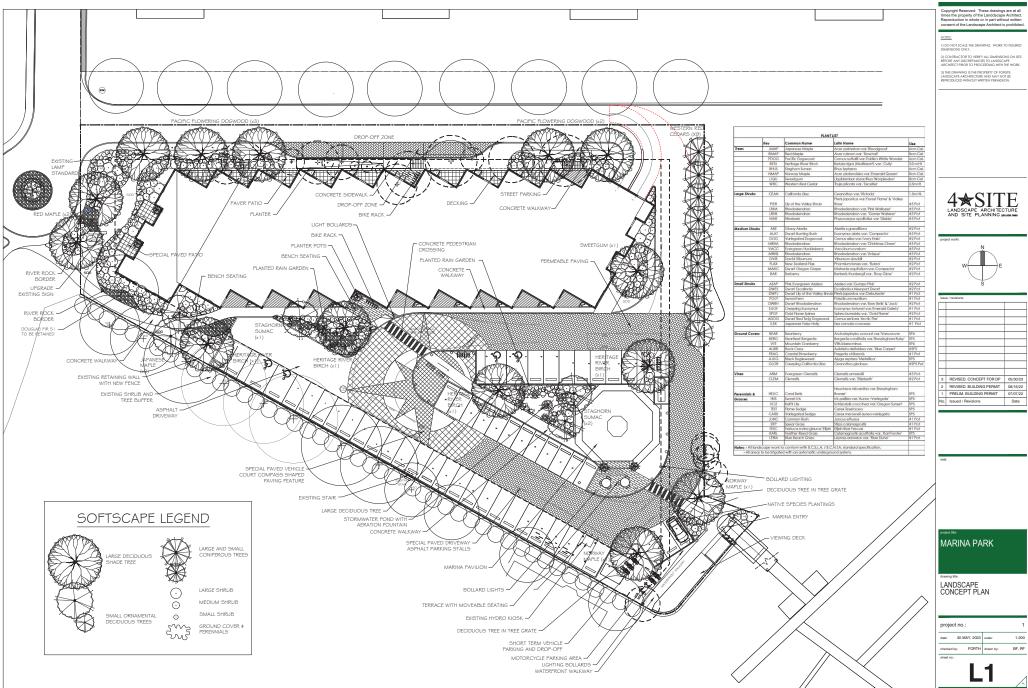
